#### **PURPOSE**

For Council to consider further improvements to be made to the Henry Street Oval to facilitate the hosting of an AFL NAB Cup match in Northam on 9 March 2013.

### **BACKGROUND**

The AFL has agreed to allocate a NAB Cup match to Northam as part of its 2013 fixtures. It has proposed a match between Fremantle Dockers V Western Bulldogs to be schedule for 9 March 2013.

To facilitate this match a number of improvements will be required, especially to the existing playing surface together with a suitable fence of the ground perimeter.

# Outcomes Strategies:

# **BUDGET IMPLICATIONS**

Following the establishment of a required scope of works it has been estimated that an amount of approximately \$105,000 will be required to undertake the required turf enhancement, earth banks and fencing. Council has previously approved funding of \$35,000 for turf works and the existing budget provides \$15,000 funding for fencing.

The revised budget is as follows:

The Recreation and Community Facilities Reserve has a balance of \$396,128.

## OFFICER COMMENT

The additional cost over and above that previously approved is a result of closer examination of the soil and these works would be expensed against the existing budget provision for ground maintenance. The perimeter fence upgrade is required for the elite player group as it helps them visualise the boundaries, it will also add significantly to the appearance of the oval.

In order to establish a uniform playing surface it will be necessary to remove some 150mm of old turf and clay based soil and replace with clean sand. It is anticipated that that to purchase, cart and spread this sand will add some \$43,000 to the project. Moreover, it is expected the fence will cost \$30,000 to purchase materials and we would be relying on volunteer support to erect.

Other matters such as goal posts (supplied by AFL) ground signage, etc will be sourced from existing provisions and contribution of volunteer labour.
