MULTIPLE DOG APPLICATION (Companion, Working Dog)

Requirements to keep more than 2 dogs (3-6)

Please read the following information carefully:

- 1 The application fee for a multiple dog application is \$70.00 *all dogs over the age of three months must be registered* prior to application. (non-refundable)
- 2 Applications for more than two dogs or 3-6 dogs must be for (companion, working dogs) multiple dogs for breeding, racing or commercial purposes (ie not just companion dogs) relate to a kennel.
- 3 When a multiple dog application is received, Shire staff will contact all neighbours, whose boundaries are within a 50 metres radius of the applicants' property boundary, seeking feedback on the proposal.
- 4 Once all paperwork has been collated, Ranger Services will notify the applicant of the progress, and make arrangements to inspect the property.
- 5 If there are no objections and Ranger Services are satisfied with the premises, an approval will be granted.
- 6 If there are objections, or Ranger Services are not satisfied with the premises, the application will be submitted to Council for their decision. It is up to the applicant to confirm when the application will go to council, if they wish to attend. Agendas are available on Council's website www.northam.wa.gov.au
- 7 Any proven complaints from neighbours regarding your dog's offending against the Dog Act 1976 or Shire of Northam Local Laws, could see the permit being revoked and the numbers having to be reduced to a maximum of two within 14 days.
- 8 Once approved, the applicant must hold and maintain valid registrations for each dog kept on the premises, the exemption is only valid for the life of the dogs, should any of the dogs die, be sold, go missing or given away, it cannot be replaced prior to seeking further approval.
