6. AGENDA ITEMS

6.1 PLACEMENT OF HUGO THROSSELL VC AND SIR JAMES MITCHELL PORTRAIT

BACKGROUND

The Art Collection committee made recommendations to Council regarding the placement and location of the Hugo Throssell VC and Sir James Mitchell portraits. The committee made the recommendation for the portraits to be hung in its original home of Northam Town Hall, providing it is placed in its original position, so as to ensure it is kept in a secure place that is also available for public viewing.

At the Ordinary Council Meeting held on 17/10/2012, Council made the amendment that the issue relating to the location of the portraits Hugo Throssell VC and Sir James Mitchell be referred back to the committee for its consideration of alternative location of display.

Mr Letch suggests the Northam Library as a suitable location for the Hugo Throssell portrait.

6.2 LETTER FROM NORTHAM RSL

BACKGROUND

A letter was received from Northam Sub Branch Returned and Services League regarding a number of issues concerning the Hugo Throssell VC portrait and its location. Northam RSL suggested until a prominent but safe location can be decided the Northam Shire could commission a professional photographer to take a good quality image of the actual painting and to present copies of that image to local groups such as the Northam RSL, A.V.A.S., The Historical Society and the Museum at the Old Railway Station, to display at their locations.

Another item was the idea to have made a life sized brass statue of Throssell to be displayed in Northam. Reg Stevens from Northam RSL will be contacting Hon Max Trenorden to see if a committee should be formed to initiate this project. Reg has asked if the Shire would be interested in having membership to this committee if it was formed, and if the Shire would support by committing funds to the project.

BACKGROUND

Members from the Northam Memorial Hall Advisory Committee have requested that arrangements be made for the pictures that were removed from the hall are returned. They believe there were 7 pictures in total, however from memory they can only recall;

6.5 COPIES MADE AND FRAMED OF HUGO THROSSELL VC PORTRAIT

BACKGROUND

Mr Letch suggested the consideration of making two copies of the Hugo Throssell VC portrait which would be framed and displayed at the Northam R.S.L and the railway museum. The approximate cost to undertake these works would be approximately \$450.00 each.

It was decided at the Art Collection committee meeting held on 27 September 2012 that quotes would be obtained before making a recommendation to Council. This was questioned by Cr Beresford whether copying the works would reduce the value of the original, and Ms Ashman also raised questions regarding copyright.

Cr Rumjantsev requested the consideration for the high quality reproduction of two copies (costs from Churchill galleries as suggested by Ann Ashman) e.g. RSL hall, Visitor Centre.

At Council meeting held on 17 October 2012 Council endorsed the recommendation to Council for the inspection and photography work for the water colour paintings. This work would be undertaken at a cost of \$2,082.00 which would be deducted from the general ledger account 11362022. This account was allocated a sum of \$2,714.00 for the 2012/2013 financial year with a variance of \$413.10. There is a remaining sum of \$218.90.

With regards to the reproduction of these artworks, Council resolved on the 18 April 2012 the following;

That Council,

- 3. endorse the Art Collection Committee recommendation in accepting the request from the Northam Sub Branch Returned and Services League, to display the portrait of Mr Hugo Throssell VC in April 2015.
- 4. endorse the Art Collection Committee recommendation in accepting the request from the Northam and Districts Historical Society to display the portrait of Mr Hugo Throssell VC and Sir James Mitchell in the Northam and Districts Historical Society's room upstairs in the Northam Town Hall, for a term specified by Council officers.
