OFFICER'S COMMENT

2017/18 season has been a fairly quite season without any major incidents to report.
 It is noted that we have responded to 2 x hay truck fires, 1 x structure fire

It is noted that we have responded to 2 x hay truck fires, 1 x structure fire and several minor - moderate scrub fires.

- In January, the Shire of Northam assisted the Shire of Mundaring with a taskforce to help battle an out of control fire burning through the Mundaring Weir area. We assisted with 2 shifts and 4 appliances to assist with fire suppression.
- In February, the Shire of Northam assisted the Shire of Toodyay CBFCO with resources to assist in containing a scrub fire very close to our border on the Clackline-Toodyay Rd.
- In March, there was a reasonable sized fire in Wootatting, this fire provided difficult access for fire appliances, so in the early stages of suppression activities, we were fortunate enough to have air support on the scene, as well as resources from the Shire of Mundaring, and also from the Department of Biodiversity, Conservation & Attractions (DPAW). The extra resources allowed the fire to be contained relatively quickly to prevent to assist ground crews in mopping up efficiently.
- With the assistance of the CESM, 4 of our most active brigades have been able to purchase FLIR cameras with funds raised through conducting hazard reduction burns on behalf of the Shire of Northam. These cameras have already proven to be an invaluable tool for our brigades as it has assisted in identifying hotspots early to ensure that water resources are used effectively. With this new equipment it will hopefully mean a reduction in re-ignitions in the future.

An additional report was provided by the Deputy Chief Bushfire Control Officer (DCBFCO) at the meeting:



- Incident 1 Muluckine Road, Scrub Fire: The Grass Valley, Irishtown, Clackline, Bakers Hill Bush Fire Brigades turned out in addition to the Northam Volunteer Fire and Rescue Service. Tyron McMahon took control on arrival, however handed over to the DCBFCO after a few hours. The crews worked well into the night and change over crews were deployed at approximately 8:00am the following day. The incident ran for two days and was closed off on Sunday at 5:00pm.
- Incident 2 Goomalling Road Hay Truck Fire: The DCBFCO didn't arrive until approximately 7:30am with the CBFCO. The CESM was first on scene and the Iristhown, Clackline and Bakers Hill Bush Fire Brigades turned out in addition to the Northam Volunteer Fire and Rescue Service. Some trees were taken down by Main Roads WA and one lane was reopened the following day at approximately 9:00am.
- Incident 3 Moondyne Road, Mokine: Call was received at approximately 9:30pm for a scrub fire which was a structure fire. The DCBFCO attended with the CESM. Clackline was there on arrival and there was some confusion around what the incident was as it wasn't called in as a structure. COMMS were calling regarding the incident and Northam and Wundowie Fire and Rescue Service were deployed as it was also a structure fire. Bakers Hill and Irishtown Bush Fire Brigades attended in addition to Toodyay and a Northam Shire water truck. The DCBFCO was criticised for too many appliances, however stated that he would rather have too many than not enough, and that is the decision he will make.

OFFICER'S COMMENT

Personal Protective Equipment.

Due to a uniform audit conducted by the CESM during the 2016/17 season, it was identified that there was a critical need for new PPE to be ordered for the active members. As a result for the 2017/18 season the massive task of upgrading/replacing old or obsolete gear was undertaken and almost all of our active members have now received their gear and kit bags.

To continue to work towards our goal of increased safety and wellbeing for the volunteer fire fighters, the Shire is about to embark on an initial rollout of the Scott Pro masks to each brigade. Each brigade will have to complete a refresher which we will run annually, to refresh members about the fitment, cleaning and maintenance of these masks to gain the maximum service life out of the new equipment, and to ensure they are kept in operational condition for the benefit of our volunteers. The masks are a one size fits most, however we have purchased an additional ten size S masks to issue to members that require them to ensure proper fitment with adequate face seal to ensure maximum effectiveness.

Comprehensive Crew Protection

As of March 2018, all Shire of Northam 1.4 appliances have had the comprehensive crew protection installed as part of the future fleet upgrade.

ESL LGGS Budget 18/19

The application for the 2018-19 LGGS Grant was due on the 28th March 2018. Brigades were asked to submit their wish lists with quotes by the beginning of March. Which most brigades have completed.

The Shire of Northam on behalf of the brigades submitted an application for two capital grants for the re-deployment of funds set aside in the 2017/18 budget to provide extensions to the Bakers Hill Fire Shed, to go down the more favoured option of a brand new facility in a new location to maximise the benefit to both the brigade and the community they support. In addition to the Bakers Hill facility the Shire of Northam have officially launched the Wundowie BFB. The brigade is currently made up of Wundowie VFRS members who have opted to dual register with the Shire of Northam as Bush Fire Service volunteers also. This brand new brigade currently has almost 15 members, with more expected as the brigade grows. On behalf of the Wundowie BFB the Shire of Northam has applied for capital funding to build a new facility in the Wundowie town site, a business case has been put forward for the new facility and appliances and updates on progress will be provided at subsequent BFAC



meetings. In the interim the Wundowie BFB members will operate high season appliances as they become available and will be utilised a relief/stand in crew to man any Shire appliance that the brigade may not have crew to man. Members will be collected by the CESM or CBFCO if required to drive any spare appliance during an incident. There was also numerous items in the \$1,200 to \$5,000 operating grant.

Training

DFES Training calendar for 2018 is out. I have emailed a copy on to all brigades. Members are encouraged to login to E-academy to book a training occurrence. Additional to the regional training, I'll be teaming up with the Area Officer Upper Wheatbelt to conduct some extra training courses, specifically targeting the following competencies,

- Intro to Fire Fighting;
- Bush Fire Fighting;
- Structural Fire Fighting; and
- Basic WAERN

I have chosen these courses as we are hoping to recruit new members over the winter months, this will get them trained faster, with the intent on keeping all new or potential new members engaged with their brigades as we enter the 2018/19 bush fire season.

Emergency Service Directories

In January 2018, the Shire of Northam took delivery of the latest Emergency Service Directories. These have been issued to all Shire bush fire brigades and placed into the appliances for use by members navigating to incidents.

BART - Emergency Response App

In December 2017, the Shire rolled out the BART emergency response app. This app is used to assist with turnouts as the first arriving on station can know at a glance what other personnel may be attending the callout. This gives them the opportunity to make contact with the CBFCO/incident control before initial turnout to advise a possible delayed response or indeed a situation where no crew is available. The CBFCO/incident controller can then form a strategy based on the known resources available to them, to assist in making alternative arrangements f required.

Collar Tank for water bombing aircraft

The collar tank that has been in storage in the sea container at the Northam Airfield has been removed due to space constraints in the sea container.

The collar tank is currently sitting at the Northam Regional Office awaiting testing to confirm serviceability. Once the test are complete and the tank is confirmed operational, I will have a discussion with DFES managers to determine the best place for storage within the region to ensure rapid deployment should the tank be requested. I have considered the possibility of



storing in a maxi crate and possibly permanently storing on the Shires 12.2 water cart to guarantee the unit being available if called upon. I'm open to ideas and suggestions from BFAC members as to an alternate storing method and am happy to look at all options presented to me.

<u>Bush Fire Manual</u>

The bushfire manual is now at a point where it is ready for workshops with brigade members to make any necessary adjustments/changes prior to the completed document being submitted to Council for adoption.

This manual has been developed to make it easier for our brigades to find information they may be seeking on Council polices, and relevant legislation etc. and formatting it into one easy to read document that is readily accessible as each station will have a hard copy which will be available to all members upon request.

Volunteer Firefighters Dinner

The 2018 Firefighters Dinner will be held on Friday the 25th of May at the Northam Recreation Centre. The dinner will be an opportunity to relax and socialise with volunteer members from all brigades, including VFRS brigades. I hope to build on the solid base set by last year's event, and I'm looking at incorporating a few activities into the night to build on the friendly atmosphere. More details will be provided by the end of April when the official invites are sent out.

Hi Daniel & Chadd

It is getting to that time of year again and we are into the final preparations for our 2018 prescribed burning program.

As with last year we have built the program with a large number of burns, with the intention of commencing some in autumn and then continuing them through winter and into spring. Some of these burns include sections of tenure managed by the Shire (Road Reserves and small sections of Shire managed crown reserves). Therefore we are seeking permission to potentially burn the affected Shire managed reserves in 2018.

Also, we have included your contact details into the prescriptions so you will receive notification when we are planning to implement any of these burns and, as with previous burns, the brigades are always welcome to attend and assist at these burns should you wish.

I have attached a summary of the affected sections of Reserve that may be burnt during the burning operations as well as maps of the relevant proposed burns.

P.s. In addition, as part of the burning operation, where roads are affected, we will be implementing the Department's "Prescribed Burning Traffic Management Plan", developed in accordance with the Main Roads Western Australia Traffic Management for Works on Roads Code of Practice (2009) and Australian Standard 1742.3-2009. These TMP's will be installed by staff trained to "Basic Worksite Traffic Management" qualification as a minimum.

I have attached a copy of the Risk Assessment and Treatment Schedule for all of the affected Shire managed roads, completed in accordance with the Traffic Management Plan.

We will also keep you informed should any Traffic Control Plans be implemented.

Please let me know whether you are happy for us to include the sections of reserve (and implement the Traffic Management Plan) as shown in the attachments as part of our 2018 burning program.

BACKGROUND / DETAILS

The Shire of Northam is in the process of preparing the Bush Fire Manual which is a new document that proposes to consolidate all issues relating the operation and management of Bush Fire Brigades within the Shire. The manual will bring together all associated documents that relate to the operation of Bush Fire Brigades. As an example this would include the existing Bush Fire Brigades Administration Procedures Manual, BFAC Terms of Reference, existing Council policies, Bush Fire Response plan and current and proposed standard operating procedures.

The Manual would also provide a "one stop shop" for all new and existing members to obtain all the necessary information on the bush fire related matters. At the moment there is a number of different documents that impact on the operation of the Brigades and this proposes to bring them into one document.

At the current time the Manual will comprise the following sections -

- 1. Introduction;
- 2. Bush Fire Response Plan (previously the Bush Fire Management Plan);
- 3. Bushfire Policies and Procedures (this section will include any existing and proposed policies adopted by Council and proposed standard operating procedures);



- Bush Fire Risk Management Plan (this is a new section that refers to the plan being produced through the Bush fire Risk Management Planning team);
- 5. Bush Fire Brigades (this section will include the existing Administration Procedures Manual and relates directly as to how individual brigades operate);
- 6. Risk to Resource Document (this will be an updated version of the 2010 document);
- 7. Local Government Appointments (this section will include information on how FCO's are appointed and the BFAC Terms of Reference);
- 8. Contacts and Resources (this is directly from the Shire of Northam Local Emergency Management Arrangements);
- 9. Volunteering (this section includes the existing Shire of Northam information on OHS and Code of Conducts etc.);
- 10. Legislation (this section will reference the existing Bush Fires Act 1954 and Associated Regulations); and
- 11. Appendixes (this section will include various forms and templates referenced in the Manual).

OFFICER'S COMMENT

The Bush Fire Manual brings together multiple Council documents and policies and BFAC decisions into one easy to read document, so bush fire members and new members can be given this document and know all there is to know on policies and procedures for bush fires within the Shire of Northam.

This document is hoped to be for the Brigades by the Brigades to help members to understand their roles and procedures.

The process proposed is as follows:

- 1. Workshops will be held to review individual sections of the Manual to prevent overload at workshops.
- 2. Brigades are to select 2 members, which can include their BFAC representative, who would be the best member to provide feedback on the document on their brigade's behalf at the workshops.
- 3. The sections to be discussed will be sent to each Brigade prior to the workshop.
- 4. Brigade members will give feedback on sections they wish to discuss to Brigade representatives to be tabled at the workshop.
- 5. Discuss the sections queried by the brigades and discuss these sections at the workshop, to ensure by the time the workshop is completed, the document will not require significant changes and discussion by BFAC.
- 6. BFAC approval and council endorsement.

The Bush Fire Manual consists of current council plans and policies and decisions of council advised from BFAC.

Workshop 1 will deliberate on -

- Section 2 -Bushfire Response Plan (Update of the 2010 Bushfire Management Plan)
- Section 5 -Bush Fire Brigades (Minor changes (highlighted) and ease of reading to the previous Bushfire Administration Manual)
- Section 7 Local Government Appointments (proposed additional clarification on selection of Bush Fire Control Officers and BFAC Positions (New)

Workshop 2 will deliberate on -

 Section 3 -Bush Fire Policies and Procedures (Mostly New, some policies will move over from existing Council Policies, new Standard Operating procedures)



Workshop 3 will be held at a later date to discuss -

- Section 6 Risk to Resource (update of 2010 version)

(1) A local government may from time to time appoint such persons as it thinks necessary to be its Bush fire control officers under and for the purposes of this Act, and of those officers shall subject to section 38A(2) appoint 2 as the Chief Bush fire Control Officer and the Deputy Chief Bush fire Control Officer who shall be first and second in seniority of those officers, and subject thereto may determine the respective seniority of the other Bush fire control officers appointed by it.

Once the Fire Control Officers have been endorsed by Council public notice will be provided.

Risk Implications

Council are requested to endorse the Fire Control Officers as detailed in the recommendation which is in accordance with the position set by Council in relation to the minimum training requirements in order to minimise any potential risks.

OFFICER'S COMMENT

The recommendation for FCO's that have been received are listed within the recommendation of this report. Where a nominee has not achieved the minimum training requirements as prescribed by Council, they have been listed as a permit officer only until the requirements have been met.

It is proposed that the Committee recommend to Council those nominations received on the proviso that prior to being officially appointed the individual must provide evidence that they comply with the stipulated training requirements. If the members cannot achieve that standard then they will not be eligible to hold that position.

Discussion was held around training requirements to enable permit only officers to be fully operation FCO's. The Community Emergency Services Manager agreed to investigate what further training is required for the permit only officers and liaise with them to organise the necessary training. The A/Area Officer Upper Wheatbelt agreed to hold night training to enable this to occur, it was advised that they would ideally need a minimum of 4 or 5 people and with some courses 6 or 7.

7. URGENT BUSINESS APPROVED BY PERSON PRESIDING OR BY DECISION

7.1 BAKERS HILL – AUXILIARY PUMP ON TRUCK

It was raised that the Committee agreed to write to DFES in relation to the issues. It was queried whether this had occurred. The Community Emergency Services Manager advised that the letter has not yet been sent however will be undertaken over the coming week.

7.2 DEBRIEF ON FRIDAY, 13TH APRIL 2018

The Chief Bush Fire Control Officer reminded members of the debrief being held and encouraged attendance and/or requested or send any matters to him.

7.3 BURNING ON SUNDAYS, BANS AND FIRE PERMITS

It was raised whether burning on Sunday is now permitted. The A/Area Officer Upper Wheatbelt advised that this was granted at the last Committee meeting and endorsed by Council.

It was queried whether the east and west of the Shire should be considered separately when imposing bans and issuing permits due to the conditions often being different at each end. The committee generally agreed that this may cause more issues. The A/Area Officer Upper Wheatbelt advised **that permits can be issued with conditions to allow the FCO's to have** control where and when people can burn (e.g. allowing permits to be issued for agricultural, commercial purposes so that it is not too restrictive). The A/Area Officer Upper Wheatbelt advised you cannot split the Shire in **terms of the restricted periods as it would be difficult to 'draw the line'** without causing frustration for landowners (i.e. neighbour can burn, but they cannot). It was further advised that it can be opened up 2 weeks earlier depending on conditions.

7.4 IRISHTOWN SHED STATUS

It was raised whether this has progressed. The A/Area Officer Upper Wheatbelt advised that an agreement needs to be made with the Progress Association in order for the land to either be owned or leased by the Shire of Northam.

7.5 SCHEUDLING OF BRIGADE AGM'S

It was raised whether these needed to be rescheduled to tie in with the Committee meeting and FCO nominations. The A/Area Officer Upper



Wheatbelt advised that the FCO's were considered at this meeting rather than June due to allowing the brigades to make informed decisions in relation to nominating the Chief and Deputy Chief Bush Fire Control Officers as the Fire Control Officers will be endorsed by the June meeting.

7.6 ISSUING OF PERMITS AND PERMIT REQUIREMENTS

It was raised that there appears to be issues around communication with a permit holder and FCO if this is amended once issued. An example was provided with a permit issued to Angus Cooke where this was amended and no communication of this.

Discussion was held around the condition on permits, in respect to the equipment on the fire ground (plough, loaders etc.). It was raised that there needs to be some consistency however in some cases the conditions imposed are not practical and there is a lot of red tape. The A/Area Officer Upper Wheatbelt advised that there should be at least 2 water or 1 water and 1 machine available in order for a permit to be issued.

It was raised that there is consistently not enough information on permits and this is an ongoing issue. It was suggested that some training be held in relation to permit writing.

The Chief Bush Fire Control Officer advised that he will contacting FCO's over the coming week in relation to the burning periods.

7.7 ASSOCIATION OF VOLUNTEER BUSH FIRE BRIGADES WA- DAVE GOSSAGE

Mr Gossage provided some background in relation to his career/involvement in Bush Fire Brigades and Local Government. It was advised that he is the President of the Association which is made up of volunteers and also a Chief in a Local Government District.

BART and SWIFT Sytems

Recommended that this be investigated to assist in managing bush fires. It was advised that the group call system is being turned off by Telstra in February 2019.

Bush Fire Brigade Authority

It was advised that if a fire is outside a gazetted fire area, it is the brigade's responsibility.

<u>Manuals</u>

It was encouraged to not create so many to the point that it becomes excessive and harder for volunteers. It was raised that Local Governments have a tendency to 'cover themselves'.



Training Records

It was queried who's records these are. The Community Emergency Services Manager advised that they are DFES records. It was recommended that the local government maintain and update their own records, as DFES are bound by confidentiality and if something goes wrong they are not obligated to provide you with information.

CESM Program

It was raised that this has become a city centric model and they are working on getting the resource and funding to support the brigades. Reference was made to the Fire Prevention Officer Program and the aim is to have the intent of this program.

Risk to Resource

It was raised that this is fundamentally flawed and will be changing. It was advised that the local government is responsible for the brigades, not DFES and they are to ensure they have the necessary resources to perform the function required of them.

FCO Training

It was raised that this is being investigated and is likely to revert to the old 1 to 12 system with FCO's completing the entry level course and anything further to this is completed in at any time and order.

Bush Fire Service Medal

It was advised that this is progressing and it is hoped that this will be announced in the near future.

Red Cross Ready

Encouraged members to forward this invitation to their friends and family members.

Infrared Cameras

Advised that they have secured these at a price of \$1,000.

<u>Header Fires</u>

There has been a solution found to these which is placing a plate under one section of the comb.

<u>Chainsaws</u>

Advised that brigades can have these providing they have undertaken the necessary training.

Mitigation Funding

Advised that they are working on securing more funding for local governments and brigades.



WALGA / ESL

Advised that they have been working closely with WALGA. They are not sure how the ESL funding will pan out however they are pushing for a balance and are committed to securing more funding.

<u>ESL Manual</u>

Advised that this is quite restrictive and they are working towards this being more consistent with the Emergency Service Act.

Fit for Purpose Vehicles

It was raised that there are a number of issues across the state, with a prominent issue being due to the trucks not being made for off road use.

Website and Newsletter

Encouraged members to look at their website and newsletter to keep informed. They will be providing free training which will be listed within this.

Encouraged members to look at their website to find information and updates. They will be providing free training which will be listed on their website.

Emergency Services State Conference

It was raised that the annual conference will not be held this year due to the Australasian Fire Authorities Council holding their conference in WA.

Insurance Myths

Advised that the coroner does not attribute fault and looks at the cause however can make recommendations for matters to be investigated. It was raised that the Bus Fires Act is a very protective piece of legislation.

<u>Rural Fire Service</u>

It was advised that this will be implemented however the detail is still unknown. As soon as the Association knows this will be communicated.

In conclusion, it was raised that the Association is working closely with the Commissioner and achieving positive outcomes for brigades. It was advised that they are here for the brigades and can be contacted for advice or information.

Discussion was held around training. It was queried what can be done if DFES don't have the training records. Mr Gossage advised that completing a Statutory Declaration is sufficient providing you know the date you attended and can name somebody that you attended with. It was also advised that the training structure will be changing and will be more practical than theory.
