

##### 13.1.1 Northam Chamber of Commerce Key Performance Indicators

Clarification was sought in relation to:

- Whether the KPI's are too easy. The Chief Executive Officer advised that it is up to each Elected Member to assess if they are sufficient prior to deciding. It was advised that Council should consider the fact that the Chamber does not answer to Council as they are their own entity, which has been reflected in the KPI's.
- Whether the newsletters and emails suffice as contacting the members. The Chief Executive Officer advised that it is up to the Chamber how the communicate with members and potential members. This KPI was included to ensure those who are paying the differential rate are communicated with.
- How the KPI's were developed. The Chief Executive Officer advised that these were predominantly developed by staff in consultation and agreement with the Chamber, per the Council resolution.
- Whether something should be included to move towards self-sufficiency. The Chief Executive Officer advised that this would need to be looked at individually as there was nothing in the previous Council decision for Officers to explore that direction. It was advised that this could potentially be looked at in final year of funding.

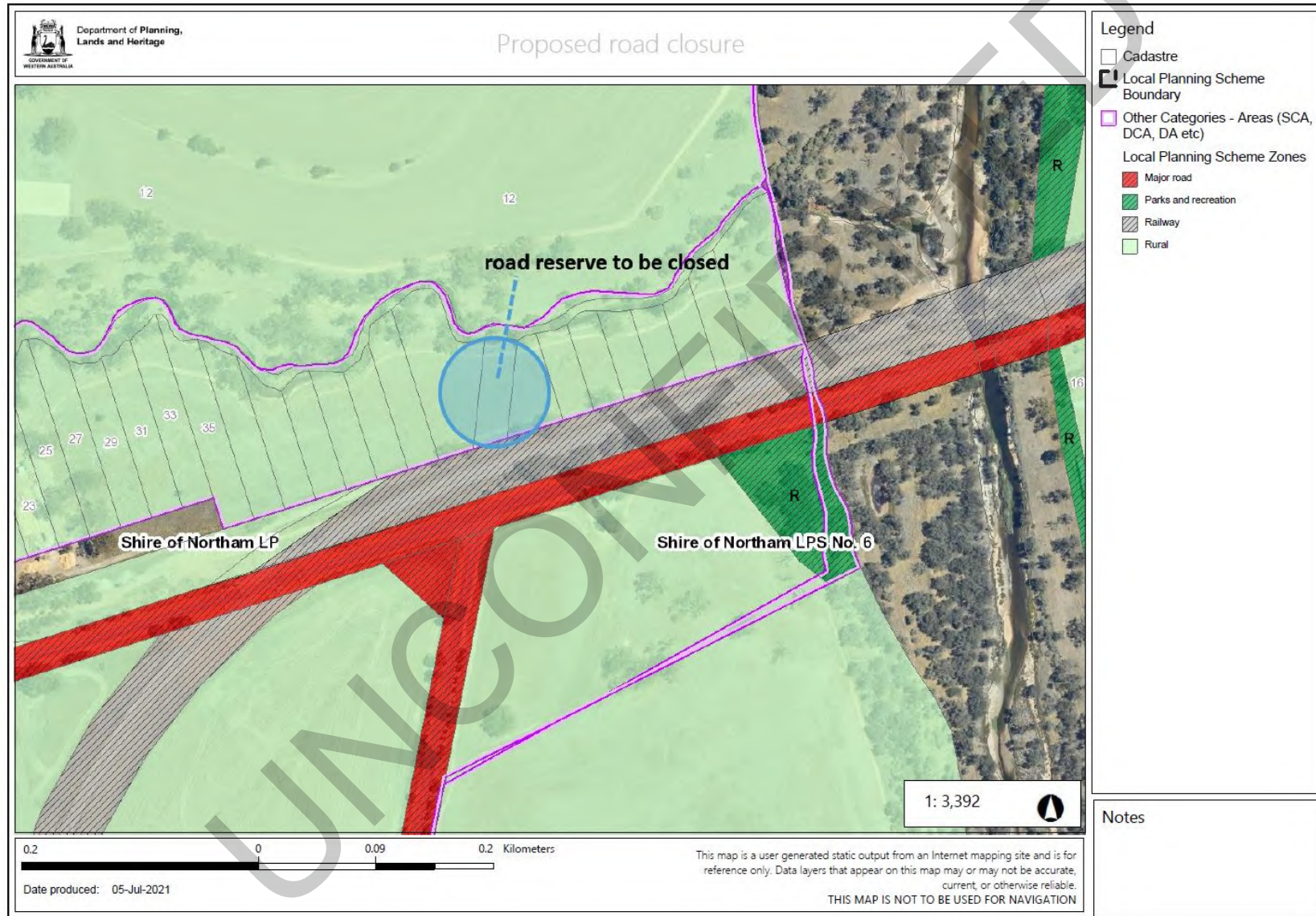

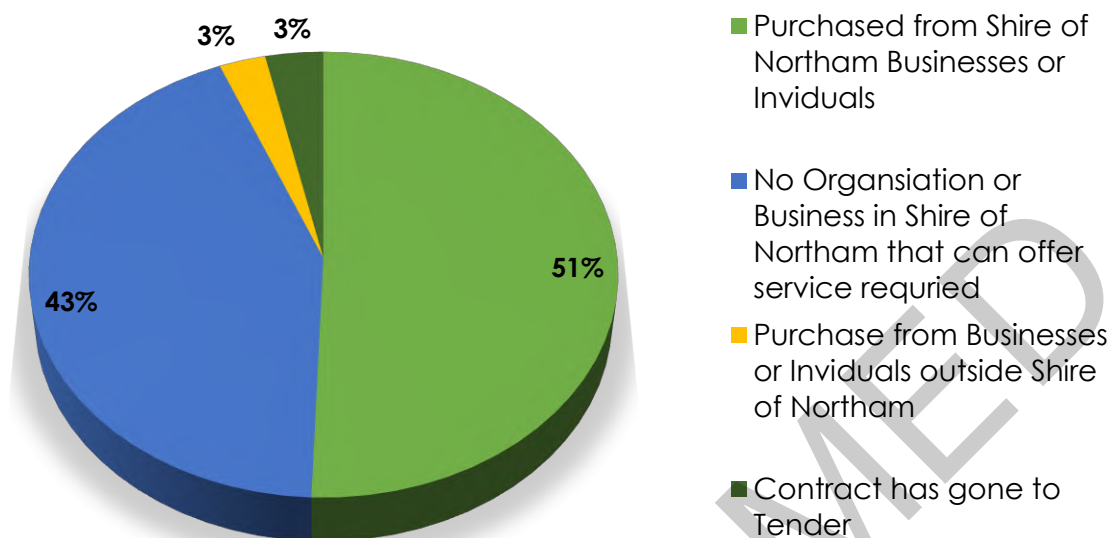

#### A. BACKGROUND / DETAILS

The reporting of monthly financial information is a requirement under section 6.4 of the Local Government Act 1995, and Regulation 34 of the Local Government (Financial Management) Regulations.

### Operating Income

1. **Governance Revenue is \$61,529 over budget due to the receipt of maternity pay from the Government of \$13,458, the grant of \$35,000 from the Department of Primary Industries for the Planning trainee (2 years), and a Workers Compensation rebate of \$10,957 from 2019/2020.**
2. **General Purpose Funding Revenue is over budget by \$1,785,989 due to FAGs grants prepayment of \$1,796,213**
3. **Law, Order and Public Safety is under budget by 34.98% due to DFES Grants receipts timing Fire Mitigation \$198,220 (cfwd), Standpipes Invoicing yet to be invoiced for June, Fire reduction on charge \$15,025, Capital Grant Bakers Hill Fire Shed yet to be invoiced , \$460,055, The light tanker budgeted is not longer being supplied and the Clackline Kitchen(cfwd). The CCTV in Wundowie retentions are yet to be invoiced and the balance carried forward.**
4. **Health revenue is under budget by \$47,410 due to health licences of \$32,446 and reimbursements of \$23,886.**
5. **Recreation and Culture revenue is under budget by \$464,055 due to the transfer from public open space, for the old pool site and the improvement for Dr Dunlop park for \$146,500(cfwd), the profit on sale of Yilgarn Avenue \$318,000(cfwd).**
6. **Transport revenue is under budget by \$305,662, due to the LRCI grant of \$207,430(timing) .Main Roads commodity route and regional road group yet to be invoiced (\$108,479)**
7. **Other Economic Services is under budget by \$144,139. The waste water treatment grant was repaid and it is anticipated that it will be awarded next financial year .**
8. **Other Property and Services is under budget by \$26,827. Insurance claims are awaiting finalisation on receipt and payment of creditors invoices currently outstanding.**

### Operating Expenditure

**It is anticipated that there are still a number of outstanding creditors invoices not received or processed for the current financial year that will affect the closing position.**

9. **Governance is under budget by \$1,680,473. This is the Covid 19 amount of \$1,485,892 under budget, together with a higher administration recovery of \$197,406(non- cash).**
10. **General Purpose Funding is under budget by \$99,054 due to valuations and title searches being under projected costs of \$90,822. This appears to be more an error in the budget projections as an assessment of previous year trends indicates that valuation and title**



search costs are incurred toward the end of the financial year (last quarter). Legal costs recoverable are \$14,754 under budget.

11. Law Order and Public Safety is under budget projections for \$308,737 this predominantly relates to fire mitigation expenditure, \$478,288, which was projected to be incurred however has been deferred until after the current fire season. In addition, the timing of Bush Fire Brigade general expenditure resulted in the expense being over budget by \$38,890. This amount has been approved for reimbursement by DFES this financial year. **The loss on the DFES vehicle trades for two fire tenders was \$128,077. The trade in amount is determined by DFES and the timing of exchanging vehicles is under their direct control.**
12. Health is \$62,598 under budget due to salaries and superannuation of \$42,043 due to the staff vacancy that has now been filled, and legal fees of \$25,000.
13. **Education and Welfare is under budget by \$147,438.**
  - **Salaries, wages and superannuation are \$75,317**
  - **Training and conferences \$10,000**
  - **Staff costs \$5,074**
  - **Office Expenses \$11,460**
  - **Non recurrent expenditure \$9,554**
  - **Bernard Park Play Centre \$41,287**
  - **Youth Services \$3,617**
  - **Senior Citizens \$4,327**
14. Other property and services is over budget by \$540,510 predominantly due to the timing of internal allocations public works overheads allocations \$154,311 (non-cash) and workers compensation expense of \$192,639. Insurance Claims are over budget by \$31,884 (reimbursable) Staff meetings are over budget by \$64,727. Supervision salaries are over by \$37,680 due to the payout of termination pays and maternity pay (reimbursed). Admin allocation is over budget by \$25,663(non-cash)

#### **Operating Income by Nature and Type**

15. Operating Grants and subsidies are over budget by \$1,327,206 as disclosed in items 1,2,3,6 and 7.
16. Interest Earnings are under budget by \$26,381 due to interest on reserves of \$31,324. This is due to a lower than anticipated interest rate on investments. Interest on late payments is over budget by 3,536.

#### **Operating Expenditure by Nature and Type**

17. Materials and Contracts are under year to date budget projections by 43%, predominantly due to the items disclosed at notes 9,10 and 11 above as well as lower spending in the following items:
  - \$45,252 Street bin collection
  - \$27,450 Green waste management

- \$30,000 Governance consultants
- \$25,000 Health Legal Costs
- \$27,593 Festivals and events
- \$17,337 Australia Day celebrations
- \$20,918 Engineering consultants
- \$14,765 Environmental works
- \$39,041 Town Planning Consultants
- \$101,529 Bridge Maintenance
- \$14,216 Streets Paths and carparks
- \$21,195 Mainstreet heritage investment strategy
- \$21,112 BKB Marketing
- **\$24,388 Street Trees**
- **\$18,996 Visitors Centre marketing**

Projections are that there have been no significant material cost savings to date and as such the end of year position will be unchanged (outside of any incomplete projects)

18. Utility charges are over budget by \$161,252 due to
- \$16,929 admin telephone (includes internet and software licences)
  - \$21,937 public parks and gardens water
  - \$38,366 water standpipes (this is allocated to jobs or charged to card holders)
  - \$65,465 gas and electricity Northam Aquatic Centre. There have been gas leaks since January adding additional expense.
  - \$8,030 Reticulation water
19. Interest expense is over budget by \$28,629 due to the accrued interest and guarantee fees charged by West Australian Treasury Corporation.
20. Other Expenditure is over budget by \$357,244. This is due to the internal allocations being over budget \$232,907 (non-cash).

The declaration of AGRN962 Storm Damage and associated flooding in the Mid West and South West Land Division (1-5 March 2021) was made by the DFES on 30 March 2021. DRFAWA is jointly funded by the State and Commonwealth Governments and is providing financial assistance grants for affected Shires. The Shire has incurred a cost of \$188,785 to May 2021. The Shire funding cap has been reached and all subsequent costs incurred will be reimbursed under the Grant funding arrangement.

The final reserve transfers have not taken place, these will be addressed as part of the end of year process as will revenue recognition, capital commitments and provisions for leave.

Items that have been carried forward into the 2021-2022 financial year are noted above. A full list of carried forwards will be presented to Council at Budget Adoption.

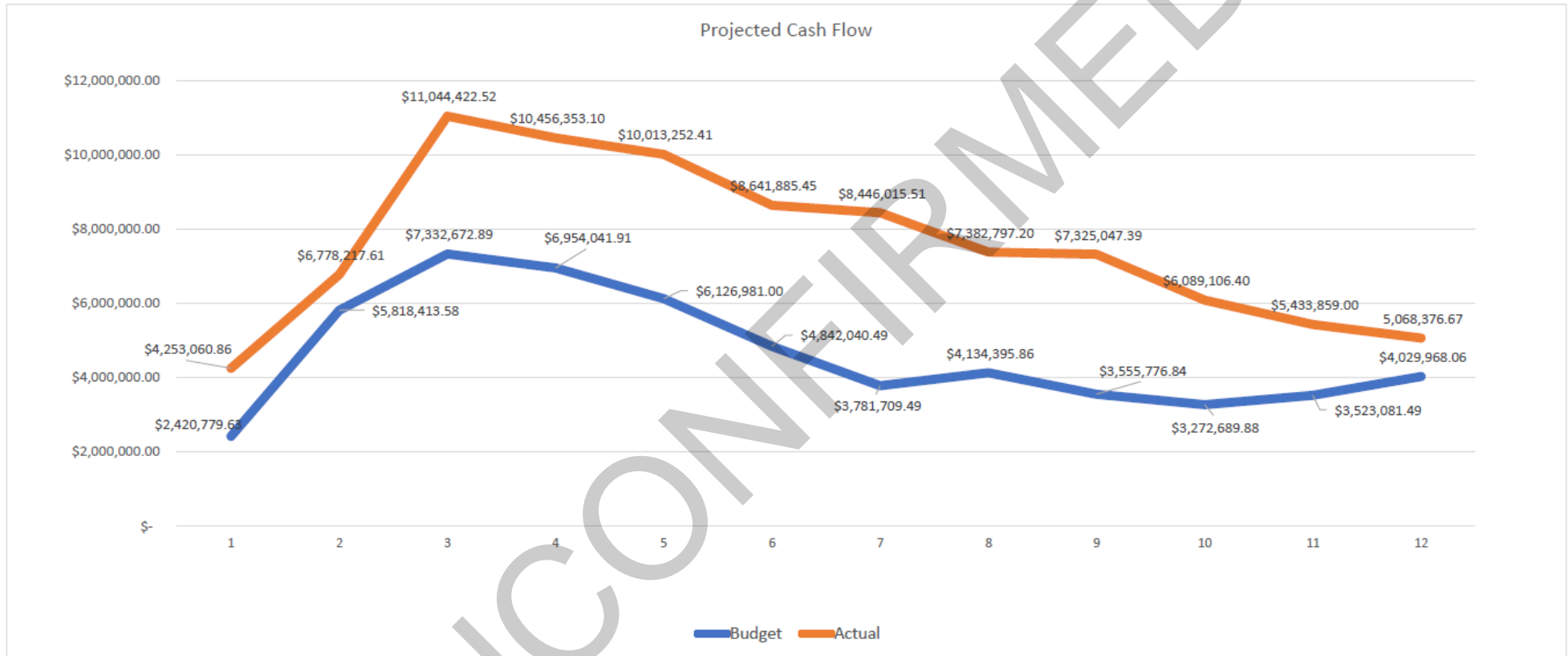

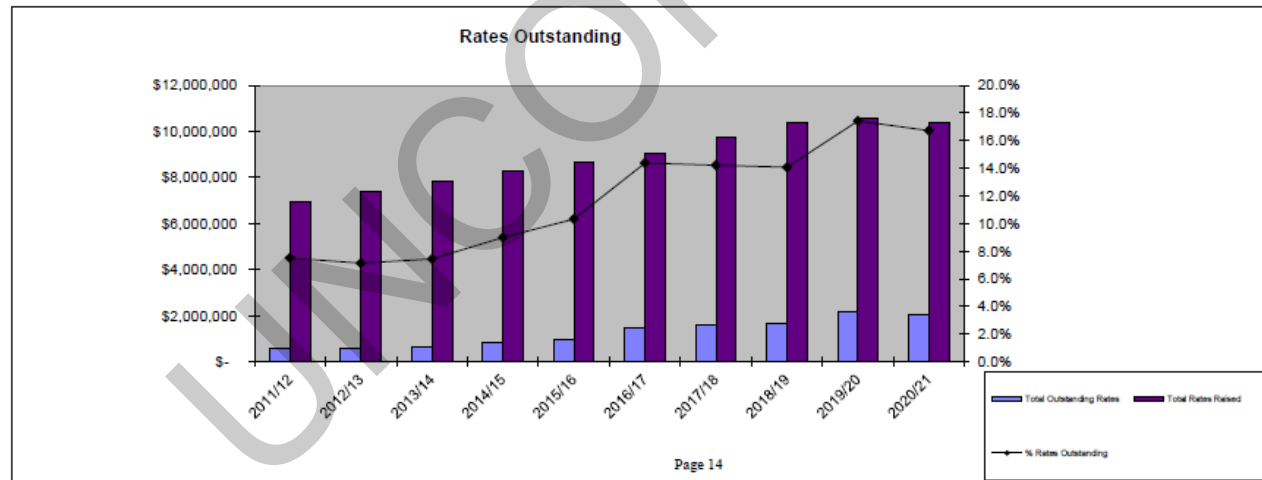
