#### PURPOSE

To provide information to Elected Members in relation to the budget process and influencing factors

#### BACKGROUND

The development of the draft budget as presented is the culmination of many months preparatory work undertaken by each individual Department under the guidance of the Council Executive Manager Corporate Services, Ms Denise Gobbart. The budget process to date has included the following key elements;

- Adoption of revised Corporate Plan
- Adoption of revised Strategic Community Plan
- Endorsement of draft road program
   Endorsement of draft footpath program
   Endorsement of draft plant replacement program
   Endorsement of draft building maintenance program
   Endorsement of Community Assistance Applications
   June 2015
   May 2015

The budget document has very much been guided by a number of key planning documents including;

- Strategic Community Plan
- Corporate Business Plan
- Long term Financial Plan

The staff have also been through a rigorous assessment process to ensure that the Departmental and individual item draft budget allocations both reflect the intent of the Councils planning document and ensure sufficient resource to meet the established objectives.

As Elected Members would be aware the long term Financial Plan reports on a number of key performance indicators, which are reflective of Local Government Act requirements. The following information provides an indication as to how the Council is performing against a number of the key indicators;

#### Debt Service Ratio

Measures a Council's ability to service debt out of its uncommitted or general purpose funds available for its operations. Councils with a higher proportion of revenue from rates can also effectively operate at lower debt service ratios as they are more able to generate income (via Rate increases) to cope with the debt burden.

If Ratio > 10	accept as reasonable
If Ratio > 5 and <10	exercise caution around debt management
If Ratio <5	debt management may be an issue and needs to be
	considered in context of overall financial position.

#### **Operating Surplus Ratio**

Effectively highlights the scale / extent of any operating surplus or deficit in relation to the overall size of the local government. A sustained period of deficits will erode that local government's ability to maintain both its operational service level and asset base.

If Ratio > 0.15	strong operating surplus which gives flexibility in relation to future operational service levels and asset base.
If Ratio > 0.00 and < 0.15	should closely monitor with improvements made where possible to increase capacity to give flexibility in relation to future operational service levels and asset base.
If Ratio <= 0.00	experiencing an operating deficit

#### Funding Ratio

Identifies the level of funding consumed by operations and capital requirements. An improving ratio means that more funds are being released for capital reinvestment.

If Ratio > 0.20% and < 0.30% If Ratio > 0.30% Base Advanced

#### Own Source Revenue Ratio

Measures the local government's ability to cover operating expenses from own source revenue. The higher the ratio, the more self-reliant the local government is. Allows greater flexibility as less external funds are required for operational purposes.

#### OFFICER'S COMMENT

There have been a wide range of factors which have influenced the development of the 2015/16 annual draft budget. The major factors, as well as other information of interest, are highlighted below;

• Salaries & Wages

In relation to wages and salaries there is a 3% increase (over the 2014/15 levels) factored into the current figures. In addition there a number of new positions as well as some rationalised positions which have resulted in reductions. The increases in staffing levels has been limited to positions which have been endorsed either directly or generally by Council previously;

- 2 Traffic Management Operators based on savings identified in the use of contractors for the road construction program (resulting in a net saving to Council)
- Part Time Human Resources Assistant 0.6 This position had been identified in the endorsed Shire of Northam Workforce Plan and in the view

of staff is warranted in the context of the workloads associated with the area.

- Trainee Surveyor / Designer for Engineering Services. This is to offset some of the loss of the Project Manager Community Infrastructure.
- The following reconciliation of wages and salaries is provided to highlight the actual increasing costs of employment for the Shire of Northam

• Previous Year Rate increases

Council has in previous years taken a responsible approach to increasing rates. The table below illustrates the Councils position over the last 4 years. The proposed 3% rate increase is in line with the parameters established within the long term financial plan.

• Projected Surplus

The current draft budget document in effect is a balanced budget, which would require **no** increase in rates. This document does take into account the natural rates growth of \$41,800 which occurred when new rateable properties were developed in the Shire of Northam. The current budget document doesn't reflect projects which are being carried forward. It is expected that an 'untied' surplus will be achieved by the Council at June 30. It is proposed that the Council allocates the untied budget surplus to a range of reserves, which Council can access in the future for specific projects, once it has been determined.

- Debt Retirement 2014/15 As Council is aware the Council retired in excess of \$1,000,000 in debt last financial year. This represented a saving in interest and principal repayments of approximately \$273,886. Given the Council long term financial plan identifies the need to leverage additional debt in future year's staff have identified these savings as a transfer to (Plant) reserve. This has been done to protect Council from over committing to operation requirements at the risk of impacting it ability to leverage required debt moving forward.
- Waste Services

Staff have identified that Waste Services as listed in Sanitation - Household Refuse should be a cost neutral service. In previous years the 'profit' made from the waste service has been used as general revenue. Future rehabilitation and development requirements at the rubbish site will potentially require significant funds, hence transferring funds to reserve is being recommended. With this in mind the draft budget incorporates a transfer to the Refuse Site Reserve of \$228,233.

#### PURPOSE

For Council to consider and endorse allocation of additional Roads to Recovery Funding for the 2015/2016 Construction Program.

#### BACKGROUND

On the 30th June 2015, additional funding was announced for Roads to Recovery increasing Shire of Northam's allocation by \$349,935 from \$732,040 to \$1,081,975.

#### CONFORMITY WITH THE STRATEGIC COMMUNITY PLAN

- OBJECTIVE (E3): Provide and support an effective and efficient transportation network.
- STRATEGY (E3.1): Plan for the provision and delivery of transport services and infrastructure in the Shire in close consultation with the State and Federal Governments.

## **BUDGET IMPLICATIONS**

The attached Appendix outlines proposed costing for the additional roads to be included in the 2015/ 2016 Draft Road & Bridge Construction Program.

These costs are based on current market or contracted rates, as well as historic data for internal construction crew's productivity and capacity.

#### OFFICER'S COMMENT

The list of proposed roads were selected based on the next highest priority which were excluded from the original Draft Program.

In addition to the revised proposed road program, the draft budget also includes the replacement of Clydesdale Road Timber Bridge with concrete culverts. This project was originally estimated to be in the order of \$108,000 ex GST based on initial estimates provided by contractors late in the 2013/2014 financial year. Once funding was confirmed staff sought detailed costings through the procurement process and determined a revised estimated budget of \$200,000 would be required to deliver these works.

The additional projects proposed to be included in the roads program total an estimated sum of \$257,214 with a balance of \$92,000 to be allocated to Clydesdale Road timber bridge replacement

#### Additional Funds announced for Roads to Recovery

As advised, the Australian Government has announced additional funds for Roads to Recovery. New allocation amounts are now listed on the Roads to Recovery website at http://investment.infrastructure.gov.au/funding/r2r/index.aspx.

There will be no changes to the requirements of Own Source Expenditure however you must continue to meet your normal obligation.

To find your Reference Amount (the amount you are required to spend of own source funds to meet the funding conditions) please check your last annual report on IMS and at part 3 it will give you your reference amount.

#### Programme requirements

#### Quarterly Reporting

The web site will be open from 1 to 31 July for the entry of quarterly expenditure reports. The next payment will be made in mid-August on the basis of the following formula:

Payment = cumulative expenditure (R2R component) by council on Roads to Recovery projects from the inception of the programme on 1 July 2014 until 30 June 2015

plus projected expenditure (R2R component) to 30 September 2015

less total R2R payments already made to council by the Commonwealth.

Please note that, all reports (annual and quarterly) are now required to be done on an accrual basis.

Please update your work schedule, including the addition of new projects, before you do your expenditure report so that funding for new projects can be provided in the next payment. Information entered on projects must be written in language that the general public can understand, not in engineering jargon.

#### Bridges Renewal Programme (BRP)

The Minister for Infrastructure and Regional Development launched round two of the Bridges Renewal Programme (BRP) at the 2015 National General Assembly of Local Government on 15 June 2015. Proposals will be called for from 1 July 2015, and the closing date is 31 August 2015.

The Australian Government has committed \$300 million through to 2018-19 for the BRP. The objectives of the BRP are to contribute to the productivity of road bridges serving local communities, and facilitate higher productivity vehicle access.

Round two is open to Local Governments only, with up to \$100 million in funding available. The Australian Government will contribute a maximum of 50% of the total project cost, Councils are encouraged to discuss the programme with local communities, relevant industry stakeholders, Regional Development Australia committees and state road agencies early in the process.

Details on the programme parameters, how to apply and funding conditions are contained in the Programme Criteria and Proposal Form. Proposal forms will be available from the open date of 1 July 2015.

#### PURPOSE

For Council to give consideration to matters raised by Elected Members and the presented consideration list for incorporation into the 2015/16 annual budget

#### BACKGROUND

All Elected Members were provided with the opportunity to attend small workshops to allow the Council Finance team to provide an outline of the budget document as presented, answer questions, and provide clarifications. These workshops were well attended and the feedback received from Elected Members has been positive.

The budget document consisted of the draft budget and a list of items for consideration. At the budget workshops Elected Members were provided the opportunity to raise/identify issues they felt warranted further detailed discussion or debate at the Budget Meeting.

As has been outlined in the previous report, the budget as it is currently presented is in effect is a balanced budget, which would require **no** increase in rates.

The budget has been developed in accordance with the broad parameters established in the range of Council planning documents.

#### OFFICER'S COMMENT

As a result of the assessments by staff and the workshops held with Elected Members the following information is provided;

- 1. There were some general comments made at the workshops which individual Elected Members asked to be raised/discussed at the budget meeting, these are disclosed below;
  - 1.1 Wages Increases

There have been queries raised in relation to no allocation being made to some salaries & wages accounts and significant increases reflected in others. For example Schedule 10 Sanitation- Household Refuse shows no salaries in 2015/16 and Schedule 7 Health Inspection & Administration shows an increase in salaries from \$168,940 in 2014/15 to \$228,809 proposed in 2015/16. In this instance, and others instances, this is simply reflecting an alteration of the treatment of salaries and wages allocations. In the above example this includes salaries for the Health and Administration Officer's. In previous years some of these salaries have been spread throughout the budget document, which makes it difficult to track and therefore manage. As a consequence they have all been brought into one account.

1.2 Killara reconciliation

Queries have been raised in relation to the cost of the Killara facility to Council. Schedule 08, page 50, of the budget shows the following figures:

Total Revenue	\$1,356,553	
Total Expenditure	\$1,441,096	\$84,543 (cost or loss)

While these figures are reflecting a net cost to Council of \$84,543, consideration needs to be given to two critical elements of this, being the Administration Allocation (\$67,659), and Depreciation (\$87,830). In the case of the Administration allocation this is reflecting a cost of 'administration' which is borne out of the general administration costs of creditor / debtor processing, accounting and payroll for example. These functions are undertaken by Council staff, who it is considered would still be employed by the Council in the event Killara was no longer operated by Council – hence this represents an accounting treatment, but a 'sunk cost'. In relation to Depreciation, this is currently not 'cash backed' and as such is an accounting treatment which is not currently representing a cash cost to Council. With these comments in mind the Corporate Plan identifies a review of the financial sustainability of the Killara business, where these matter will be further assessed.

1.3 Landfill From Other Local Governments

Is the current revenue, sufficient to cover the cost of expenses related to tip management for capacity that is being utilised from this service?

- 1.4 Parks and Gardens Purslowe Park – is there a need, no one seems to use it?
- 1.5 Town Clock Expenses related to the Town Clock were discussed. This maintenance account includes the thermometer that is located with the clock.
- 1.6 Rates Growth Property Numbers
   With the growth in rates we now have an additional 7 rateable properties.
   Most of the rates growth in the past year is based on new buildings.
- 1.7 Community Grants Discussion occurred regarding the timing of the grant applications and when the funds become available to community groups.
- 1.8 Bridge 0613 Yilgarn Avenue This is the traffic bridge across the Avon River, near the weir. Funds have been allocated by Main Roads WA to undertake a final design for works required on the bridge.
- 1.9 Inkpen Landfill Life Span Staff advise that the Inkpen Landfill site has a current life span of 5 to 7 years, based on current operations.
- 1.10 Bakers Hill Oval The need to have discussion with the Education Department regarding a contribution for the use of the oval now the facility has been upgraded.
- 2. There were a number of items currently in the draft budget which Elected Members asked to be identified for further Council consideration. These items are;
  - 2.1 Concerts in the Park Concerts in the Park maybe getting tired, should we have a break?
  - 2.2 Cricket Pitch Jubilee Oval A provision of \$27,000 has been made to install a concrete cricket pitch in Jubilee Oval. Concern was expressed as to the need to provide.
