#### **BUSINESS ARISING**

- 7.4 Digital Electronic Recording Device FM advised that one of the Brigades had linked the radio to their computer in order to record radio traffic, which may address this issue to a degree.
- 7.5 Fire Brigade Local Law FM advised that a local law is not required in order to establish brigades.
- 7.6 Response on Extreme Fire Danger Days FM advised that a working party has not been formed yet, and that a request for nominees from Brigades would be called to be in such a working party, to discuss the issue.

#### 6. AGENDA ITEMS

6.1 PROPOSED AMENDMENT TO "COUNCIL COMMITTEES & COMMUNITY BASED ORGANISATION REPRESENTATION" (PART 2 - TERMS OF REFERNCE - BUSH FIRE ADVISORY COMMITTEE)

#### Background:

The BFAC Committee Terms of Reference (as recorded in "Council Committees & Community Based Organisation Representation" document) currently require that the Chief Bush Fire Control Officer, Deputy Chief Bush Fire Control Officers, Fire Weather Officers and Harvest ban Officers are permitted to be nominated for 2 consecutive periods of 2 years each, and require these Officers to take a break period of a minimum of 2 years before being able to be re-nominated for the position.

A copy of the relevant section of the Terms of Reference is shown below.

1.5.3 Election of Local Government Officers at the Annual General Meeting to be held in April each year:

The Bush Fire Advisory Committee may forward to the Shire of Northam recommendations for the following positions which will be appointed for a period of 12 months and then may be appointed for a maximum period of 4 consecutive years and then have a break of 2 years before they can be appointed to the same position:

- (a) Chief Bush Fire Control Officer
- (b) Deputy Chief Bush Fire Control Officer (2)
- (c) Fire Weather Officers

Persons wishing to nominate for the above positions must meet the training requirements and be prepared to carry out the duties of the position.

## 1.6 Terms of Office

A person holding the position of Chief Bush Fire Control Officer and Deputy Chief Bush Fire Control Officer may seek re-election annually for a period of one (1) years making a total of 4 years in the position. After a two (2) year break from the position a person may seek re election.

This is proposed to broaden the experience of the Fire Control Officers and will help with the succession Chief Bush Fire Control Officer and Deputy Chief Fire Control Officers.

Preferably the election of Chief Bush Fire Control Officer and Deputy Chief Bush Fire Control Officer should be staggered so that one position appointed each year e.g.:-

Year 1 - Chief Bush Fire Control Officer should be declared vacant;

Year 2 – 1st Deputy Chief Bush Fire Control Officer should be declared vacant;

Year 3 – 2<sup>nd</sup> Deputy Chief Bush Fire Control Officer should be declared vacant.

## Officers Comment:

The existing BFAC rules exclude the opportunity for some individuals of certain tenures to be nominated for the position of Chief Bush Fire Control Officer, Deputy Chief Bush Fire Control Officers, Fire Weather Officers and Harvest ban Officer and were intended to promote succession planning for the position of these Officers.

As a result of this rule the opportunity for the existing officers to be nominated for the positions have been precluded without the BFAC having the opportunity to re-nominate people to the positions.

## 6.2 2011/12 FIREBREAK ORDER

#### Background:

The 2010/11 Firebreak Order was previously amended to include the following requirement:

"Firebreak Requirements - Land greater than 5ha

- Install a 3m wide firebreak clear of all flammable material except if the property is being used for pasture and cropping where the firebreak shall be a minimum of 2m in width.
- A lot greater than 200ha requires a 3m firebreak around parcels of 200ha
- Any areas of standing crop or pasture in excess of 100ha requires a 3m firebreak around parcels of 100ha"

Although the first point makes reference to a minimum 2m firebreak in areas used for pasture and cropping, the rest of the points still refer to 3m.

#### Officers Comment:

It is recommended this section be modified to remove the inconsistencies.

## **BFAC Recommendation:**

That BFAC request Council to amend and simplify the 2011/12 Firebreak Order So that all firebreak requirements are 2m in width with the exception to the access to all building and construction which will require 3m width and a 3m height requirement.

#### 6.3 IMMIGRATION YAGONGAH DETENTION CENTRE

#### Background:

The Department of Immigration (DOI) have offered to assist the Shire of Northam Bush Fire Service by providing funding for an additional fire appliance to service the area. The Clackline Muresk Bush Fire Brigade have expressed interest in receiving this additional appliance to be situated at the Spencers Brook Community Fire Shed (which is currently not a Council facility and not a Council operated Brigade).

#### Officers Comment:

Any additional appliance to be provided to the Shire under any other means than FESA's asset replacement schedule/Risk to Resource modelling would need to be funded by the Shire as it would not be eligible for ESL expenses. The acquisition of another fire appliance is supported, however further negotiation needs to be held between the Shire and FESA to ensure that the proposed appliance can be made eligible for ESL expenditure to cover operational and maintenance costs.

#### **BFAC Recommendation:**

- a) That Council write to the Department for Immigration advising that the offer of a fire appliance to the Clackline Muresk Bush Fire Brigade is supported.
- b) That Council negotiate with FESA to include this fire appliance in the ESL eligible category.
