That the Committee

- 1. Care of the Collection:
  - (a) The committee noted that Bruce Gilbert has commenced work on repair to the backs of paintings and that the work is funded.
  - (b) Cr Rumjantsev volunteered to take quality digital photographs of the works as these repairs are done. The works are to have the basic descriptions (Title and Artist) on the back.
- 2. That the Committee compile a list of suitable persons to advise on the future policy direction and content of the collection for consideration by the CEO should a fee for service be required.

**RECOMMEND TO COUNCIL:** 

1. Display of the Collection:

That Council endorse altering the small hanging tags below the frames and these be progressively removed and replaced with A5 sized provenance cards to be printed on a suitable grey background to accompany each picture – the format to be Title, Artist, Dates of artist, Précis of the artist's life and work.

2. Acquisition and Disposal:

That Council consider setting aside, as from 2011//12 Financial Year, an accumulating reserve year to year, to provide for care and maintenance costs of the Shire's Art Collection.

3. Recommending Policy:

That Council consider the long term need for a secure climate controlled storage area in some Shire building fitted with vertical sliding racks (Space required approximately 4 metres x 3 metres x 3 metres high).
