6. AGENDA ITEMS

- 6.1 The Committee briefly discussed the Skate Park on Clarke Street, and the best use of the area. Given that it is a Shire Reserve, it was decided that the status quo should remain. At 10:30am the meeting adjourned to Bernard Park.
- 6.2 The Committee visited the proposed site for the Bernard Park Sound Shell and discussed the proposal with Fiona Hogg, from Paradigm Architects. It was considered that the proposed site is most favourable, but would have to be built up by around 600mm (same level as Bernard Park toilets floor level) for a sizeable area in front of the stage, in order to have the stage at the same height as the walkway around the river, with a 900mm drop to the raised ground level at the front. It was also proposed to have two permanent changerooms one on either side of the rear of the Sound Shell, in order to retain the view through to the river. The remainder of the concept remained unchanged. Concept plans will be drawn up by the Architects and presented to the next Committee Meeting. It was not considered worthwhile purchasing the architectural plans for the design that has previously been discussed (\$5000), since there will be significant changes made. Mrs Hogg suggested from an outsider's point of view that in the future it would be worth the Shire doing up the laneway that leads from Fitzgerald Street to Minson Avenue in front of the proposed Sound Shell to provide an appealing link between the two. Mr Byfield, Mr Dempster, Cr Llewellyn and Cr Beazley left the meeting at this point.
- 6.3 The Architect and remainder of Committee visited the Northam Library, along with Wendy Porter (Librarian) and discussed the proposed extension concept. Two concepts will be drawn up, one for an extension at the rear of the Library and the second for an extension towards the Northam Gym in between the curved external walls. It is proposed that the staff area would be upstairs, and a lift is provided. The concepts are hoped to be presented at the next Committee Meeting.
