**Public Firewood Areas Order 2011**

Made by the CEO under the *Forest Management Regulations 1993* regulation 98.

**1. Citation**

This order is the *Public Firewood Areas Order 2011*.

**2. Commencement**

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

**3. Public firewood area**

- (1) The area of the Perth Hills district of the Swan region described in Schedule 1 is —
  - (a) set aside for the purposes of the collection of firewood by members of the public; and
  - (b) designated as an area to which the *Forest Management Regulations 1993* regulation 100 applies.
- (2) The area set aside under subclause (1) is delineated on the relevant DECMAPs referred to in Schedule 1.

**4. DECMAPs**

- (1) A reference in Schedule 1 to a DECMAP is a reference to a map produced by the Department of Environment and Conservation.
- (2) Copies of the DECMAPs referred to in Schedule 1 are available for inspection by the public during normal office hours at the Department of Environment and Conservation's Swan Region Headquarters, 7 Turner Avenue, Technology Park, Bentley.

**LOCAL GOVERNMENT ACT 1995**  
**AGRICULTURE AND RELATED RESOURCES PROTECTION ACT 1976**  
*Shire of Northam*  
**PEST PLANT LOCAL LAW 2011**

Under the powers conferred by the *Agriculture and Related Resources Protection Act 1976* and the *Local Government Act 1995* and by all other powers enabling it, the Council of the Shire of Northam resolved on 18 May 2011 to adopt the following local law.

### PART 1—PRELIMINARY

#### 1.1 Citation

This is the *Shire of Northam Pest Plant Local Law 2011*.

#### 1.2 Commencement

This local law commences 14 days after the day on which it is published in the *Government Gazette*.

#### 1.3 Application

This local law applies in respect of the western side of the Avon River in the district. The western side area is indicated in the diagram in Schedule 3.

#### 1.4 Interpretation

In this local law—

“**Act**” means the *Agriculture and Related Resources Protection Act 1976*;

“**authorised person**” means a person appointed by the Council under section 9.10 of the *Local Government Act 1995* to perform any of the functions of an authorised person under this local law;

“**district**” means the district of the local government;

“**local government**” means the Shire of Northam;

“**occupier**” has the same meaning as in the *Local Government Act 1995*;

“**owner**” has the same meaning as in the *Local Government Act 1995*;

“**pest plant**” has the meaning given to it in section 109 of Part IX of the Act.

“**treat**” means to take action to either—

- (a) destroy the plant so that the plant is fully and continuously suppressed and destroyed;
- (b) eradicate the plant from the land so that the land is kept free of the plant;
- (c) control the growth of the plant so that the plant does not spread.

### PART 2—GENERAL

#### 2.1 Pest plants

For the purpose of this local law, the pest plants are identified in Schedule 1.

#### 2.2 Responsibility of owner or occupier

The owner or occupier of private land has the responsibility to treat and continuously treat pest plants to achieve the required outcome.



**2.3 Required outcome**

For the purpose of this local law, the required outcome is for the owner or occupier to destroy, eradicate or otherwise control the pest plants.

**PART 3—NOTICE**

**3.1 Notice**

The local government may serve a notice on the owner or occupier of private land within the district requiring the owner or occupier to treat the identified pest plants on that land.

**3.2 Form**

The notice may contain necessary information as indicated in the form in Schedule 2.

**3.3 Compliance to notice**

An owner or occupier served with a notice under clause 3.1 shall comply with that notice within the time and in the manner specified in the notice.

**PART 4—OFFENCES**

**4.1 Failure to comply**

Where an owner or occupier fails to comply with a notice under clause 3.1 of this local law, in accordance with section 110 of the Act, the local government may treat the identified plant and recover in a court of competent jurisdiction from the owner or occupier the amount of the expense of such treatment.

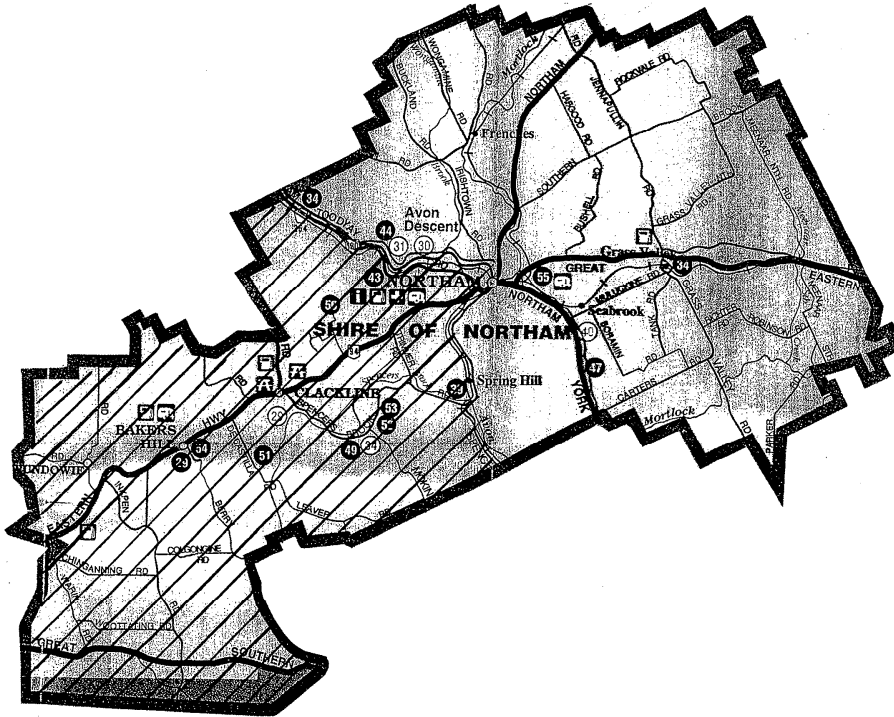

Proposed Parks and Recreation Reservation (Bush Forever Site 464—  
Mation Street Bushland)—Passmore and Holmes Streets, Southern River

**General description**

The Minister for Planning has granted approval to the declaration of a planning control area over the proposed Parks and Recreation reservation at Lots 1799, 1800, 1801 and 1802 Passmore Street and Lots 1803 and 1804 Holmes Street, Southern River as shown on Western Australian Planning Commission plan number 3.2416.

**Purpose**

The purpose of the planning control area is to protect the proposed Parks and Recreation reservation at Lots 1799 to 1804 for Bush Forever Site 464—Mation Street Bushland. The Commission considers that the planning control area is required to ensure that no development occurs on this land which might prejudice this purpose until it may be reserved for Parks and Recreation in the Metropolitan Region Scheme.

**Duration and effects**

The declaration remains in effect for a period of five years from the date of publication of this notice in the *Government Gazette* or until revoked by the Commission with approval by the Minister, whichever is the sooner.

A person shall not commence and carry out development in a planning control area without the prior approval of the Commission. The penalty for failure to comply with this requirement is \$50,000 and, in the case of a continuing offence, a further fine of \$5,000 for each day during which the offence continues.

Compensation is payable in respect of land injuriously affected by this declaration, and land so affected may be acquired by the Commission in the same circumstances and in the same manner as if the land had been reserved in the Metropolitan Region Scheme for a public purpose.
